- **13.** You <u>have never</u> been convicted of Domestic Violence.
- **14.** You <u>have never</u> been convicted of a DWI in the last three years.
- 15. You have never used, sold, cultivated, produced, or transported any illegal narcotic in the past two years.
- **16.** You have never been dishonorably discharged from the military.
- **17.** You <u>have never</u> been terminated or resigned from any law enforcement agency for any criminal conduct unless the charges or allegations were exonerated and/or cleared.
- **18.** You <u>have not</u> been rejected for employment by this agency on 3 prior occasions?
